- Pulled Pork Cook-Off Expenses: Motion to approve expenditure of up to \$2000 for the Pulled Pork Cook-Off made by Paul, seconded by John. Motion approved.
- Lake Quality Committee Bryan reporting: WSB Carp Report is pending. The loss of the fish trap has
 complicated the carp situation tremendously. The trap is not broken and does not need to be welded and has been
 set back in place following the high water surge. It is sitting on stones which allow the fish to pass through. Dan
 Cibulka (SWCD) and DNR who have mixed reviews of the continued use of the carp trap.
 - Curly Leaf Pondweed (CLP): \$17,000 was spent on CLP treatment ½ on the north side of the lake, ½ on the south side. Maximum amount allowed by the DNR was treated.
 - Eurasian Water Milfoil (EWM): Much less than expected on survey. Mostly on the north end of the lake. Plan is to treat 14.5 acres at a cost of \$8600 within the next few weeks.
- AIS Volunteer Report Background checks are being performed. John expects that we will do 75 hours of volunteer inspections to complete our Grant funding.
- LID Committee: Tabled for this year. Consider setting up a GoFundMe/a dedicated fund to grow the \$200,000 needed for 25% Grant. Ed to look for other areas of Grants that we could apply for.
- COLA Lake Stewardship Initiatives: Magnets or vinyl cling have been created To create 'Welcome Bags' with information about our lake for garnering support for fundraising.
- Chamber Music in the Park \$200 to support, no income returned. No interest.
